Basic principles and trends in family law including marriage, annulment, dissolution, divorce, child support, child custody, visitation, paternity, and adoption. Emphasis on ethical issues, drafting of appropriate documents, preparing discovery, court proceedings, computer-assisted calculation, and conducting interviews to obtain sensitive client information. The role of the paralegal in assisting the supervising attorney with practical tasks commonly associated with family law matters is explored.

Objective(s):

- 1. Utilize electronic legal research tools to obtain relevant statutes and case law needed to be referenced in legal memorandums.
- 2. Draft a legal memorandum that addresses a supervising attorney's questions regarding a Domestic Relations Court proceeding.

Course Outcome(s):

Customize templates and court forms provided by a supervising attorney with client-specific information and draft documents associated with family law matters for a supervising attorney's review.

Essential Learning Outcome Mapping:

Written Communication: Demonstrate effective written communication for an intended audience that follows genre/disciplinary conventions that reflect clarity, organization, and editing skills.

Objective(s):

- 1. Utilize client facts to customize template language of separation agreements, shared parenting plans, Domestic Relations court forms, prenuptial agreements, and Motions of Show Cause for a supervising attorney's review.
- 2. Prepare or review complaints, petitions, motions, and interrogatories associated with divorce and dissolution of marriage.
- 3. Draft an antenuptial agreement.
- 4. Draft a separation agreement.
- 5. Prepare adoption forms.

Course Outcome(s):

Analyze and explain the various ways to terminate a marriage under Ohio law and to seek post-decree enforcement of terms of divorce/dissolution.

Essential Learning Outcome Mapping:

Information Literacy: Acquire, evaluate, and use information from credible sources in order to meet information needs for a specific research purpose.

Objective(s):

- 1. Distinguish between divorce, dissolution, and annulment, including differentiation between the grounds for divorce from grounds for annulment.
- 2. Explain the legal difference between termination of marriage and legal separation.
- 3. Describe the legal significance of annulments.
- 4. Identify client needs that might indicate the use of an "alimony only" action.

Course Outcome(s):

Examine the laws, guidelines, and documents associated with parenting time in Ohio.

Essential Learning Outcome Mapping:

Information Literacy: Acquire, evaluate, and use information from credible sources in order to meet information needs for a specific research purpose.

Objective(s):

- 1. Identify and utilize the default shared parenting plan/parenting time schedule.
- 2. Examine the role of the "best interest of the child" in the context of Domestic Relations Court proceedings; abused, neglected, or abandoned children; and paternity and custody or guardianship proceedings.
- 3. Describe the legal processes used to seek assistance from Domestic Relations Court with enforcement of shared parenting plans.
- 4. Explain the Ohio court's utilization of quardian ad litems, the mandatory divorce seminar, and court conciliation services.
- 5. Analyze the state's role in determining guardianship or custody.
- 6. Identify the essential elements and functions of surrogacy agreements, as well as other "assisted conception" documents.

Course Outcome(s):

Develop proficiency in client interviewing, information gathering, and other practical paralegal tasks related to family law matters.

Objective(s):

- 1. Obtain necessary information from clients to complete basic paralegal responsibilities arising in a domestic relations legal practice.
- 2. Hold a preliminary interview with the client to identify domestic relations problems.
- 3. Record information collected during a client interview using a basic fact sheet, checklist, or questionnaire.
- 4. Develop proficiency in obtaining information needed to create a list of client assets and liabilities.

- 5. Prepare discovery materials (obtaining records, birth or marriage certificates, real estate documentation, etc.), in order to create a client asset list.
- 6. Develop proficiency in locating information associated with past and present marriages including dates, jurisdiction, children, support, custody, etc., including the materials needed to determine whether client was validly married.
